- 233. <u>County Councillors' Report</u> OCC has a new Chief Executive, Dr Martin Reeves. Bus fares have been capped at £2 (per adult single fare) from Jan-March, paid for by Government scheme and includes Oxford Bus Company & Thames Travel. A motion was carried at Full Council in December condemning the dumping of raw sewage into our waterways. Thames Water released sewage 6 times over the Christmas period. Over 75% of the 60k+ street lights under OCC control are now LED. 450 trees will be planted over the winter period supported by £185k from budget reserves. There have been incidences of failure of some trees already planted and so mention was made of the ongoing care and maintenance. OCC has successfully bid for a £5.2m grant to part fund four new residential children's homes with the matched funding by OCC still to be finalised. A draft strategy by local healthcare leaders across the health & care system in Bucks, Oxon & Berks is currently being consulted upon. Details to be included on website. And, finally, Natural England are overseeing a review process of the boundaries of the Chilterns AONB. **REPORT NOTED.**
- 234. <u>District Councillor's Report</u> A revised timetable has been agreed for the creation of the Local Plan to deliver the councils' ambitions for zero-carbon, sustainable development and genuinely affordable homes in the districts up to the year 2041, working on a county-wide plan. Developers in South Oxfordshire will now be required to contribute more to the local community following an update in the CIL charge, which is used to fund projects locally. Parking fees will increase in South Oxfordshire from 1 April 2023 which will see between 20p and 60p added to charges for users parking their vehicle. The additional revenue will be used to help maintain the district's car parks and for ongoing costs for the service.

- a. TSSC Generator Project Grants (OCC/SODC) Grant applications submitted. Awaiting determination. NOTED.
- b. <u>TSSC Parks Table Tennis Project Funding SODC</u> The Parish Council were happy to facilitate the application process to enable TSSC to obtain a Grant from SODC for the supply of a Table Tennis Table, and to have responsibility for the insurance and maintenance. The costs quoted for the provision of a concrete base, over £4,000, have not been approved or budgeted for, and will need to be funded from elsewhere. **NOTED.**
- c. <u>SODC Capital Grant Scheme</u> funding for projects that help improve people's quality of life. **NOTED.**

240. Candidate CIL Project Progress Review

- a. Village Wicket Gates Supplier quotations via OCC for purchase and installation awaited.
- b. <u>Trim Trail for Tetsworth Primary School</u> £5000 earmarked as TPC contribution towards project with caveat on future spending deadline. The school was believed to be investigating co-funding support from OCC and SODC Councillors' Priority Funds. Clarification of progress on the project awaited from school. **ONGOING.**
- c. <u>TSSC Clubhouse / TMH Sustainability Improvements</u> TPC led solar panel project. This project is not cost effective and will not be progressed. To be removed from Agenda. **AGREED UNANIMOUSLY.**
- d. War Memorial and Jitty Benches Installation of the new bench half way along The Jitty is pending as concrete base needs to be enlarged to suit. Awaiting quotation for this. Ongoing. NOTED.
- e. TSSC Generator to Satisfy Inclusion in the TPC Emergency Plan Consideration for CIL funding.
 - i. Site survey requested from Hampshire Generators and confirmation/amendment of their quote for a Warrior 11kW twin diesel and auto transfer and quote for installation and commissioning at TSSC. **Nothing Received.**
 - ii. Climate Building Services: quote to supply a 22kva Generator for installation and commissioning at TSSC. **On Hold pending TPC decision.**
 - iii. Receive other comparable quotations. Further potential supply companies identified and quotations requested.

Councillors AGREED that, due to the costs involved, the provision of a temporary Hire Unit for 'Emergency Cover' to satisfy the Emergency Plan would be more appropriate. Costings and viability of this will be investigated with a proposal put forward at a future meeting. The provision of a permanent Generator will not now be progressed.

Planning

242. Planning Applications Noted or Considered:

- a. <u>Application Ref: P22/S4379/HH:</u> Mounthill Farm 19 High Street Tetsworth OX9 7AD Internal and external alterations, including demolition and erection of single storey extensions, together with conversion of outbuilding to ancillary accommodation to the main house.
 - **Comments UNANIMOUSLY AGREED and to be submitted by the Clerk:** At the meeting of Tetsworth Parish Council on 9th January Councillors agreed that the provision of 3 parking spaces in the plan does not seem adequate or appear sensibly positioned. The Council is concerned that with already very limited parking within the village, that the residents/visitors may park in Judds Lane and/or the High Street (positioned near to the brow of the hill).
- b. <u>Application Ref: P22/S2220/FUL:</u> Dodwells Solar Farm Land north of the A40 near Cuddesdon Underground cable route to connect Dodwells solar farm to Cowley substation (as amplified by additional information received 21 December 2022).
 - **Comments UNANIMOUSLY AGREED and to be submitted by the Clerk:** At the meeting of Tetsworth Parish Council on 9th January Councillors agreed that given the Objection to Application Ref: P21/S3915/FUL TPC also Objects to this application on the same grounds.
- c. <u>Application Ref: P21/S3915/FUL</u>: Dodwells Solar Farm Land north of the A40 near Milton Common Installation and operation of a Solar Farm together with all associated works, equipment and necessary infrastructure (as amended & amplified by information received 8 July 2022 and 21 December 2022).
 - **Comments UNANIMOUSLY AGREED and to be submitted by the Clerk:** At the meeting of Tetsworth Parish Council on 9th January Councillors agreed that following consideration of this last July that the core of the Objection by Tetsworth Parish Council remains valid. Some concerns have been addressed by the developer but TPC is concerned about the number of solar farm applications within Tetsworth and neighbouring Parishes, and feels that an overall strategy, such as that submitted to SODC by TPC on 8th December 2022, should be taken into consideration.

The proposed 'Case Study of Planning & Enforcement Issues' correspondence to SODC will be finalised to provide the Chair of the Planning Committee with all details to date in respect of this property ahead of the expected Planning Committee Meeting. **UNANIMOUSLY AGREED** to sign and send.
- e. <u>Caravan</u> Sited on land at Oxfordshire Way/Stoke Talmage Road. Information supplied to SODC and now with Enforcement Team. Further vehicles have been identified on site and enforcement contacted. Awaiting any update. **NOTED.**
- f. <u>Bund</u> Proposed need for a noise reducing bund. This matter will be removed from the Agenda for future meetings until a formal proposal is received. **NOTED**
